



Member Safety Agreement

SAFETY COMES FIRST

In order to ensure the safety of our members, staff and community we are implementing new personal safety measures at Peoplefit Health and Fitness Center (“Peoplefit”):

- Stay home if you are sick or have come in contact with anyone who has tested positive or is suspected of having COVID-19.
- If you have travelled internationally or to a highly impacted area in the United States, please quarantine for 14 days prior to coming to Peoplefit.
- Temperature checks and pre-screenings will be administered prior to each visit to Peoplefit.
- Face coverings must be worn at all times. Please bring your own face covering, or admittance to Peoplefit will be prohibited.
- Hand sanitizer and disinfectants are available throughout the facility for your use.
- Follow all traffic flow patterns noted by signage and floor markings. Respect and review all signs each time you visit Peoplefit. As we move through the phases of reopening things may change often.

FOCUS ON CLEANLINESS

We are adhering to rigorous cleaning and sanitation standards in our facility. In addition to the nightly deep clean, Peoplefit will have dedicated staff cleaning high touch surfaces throughout the day. You play a role in helping us stop the spread of germs by wiping down all equipment before and after use, and washing/sanitizing your hands often.

EXPECT AND RESPECT PHYSICAL DISTANCING

In order to comply with the CDC’s physical distancing guidelines, we will be limiting the number of people inside the facility or in certain areas. All members will be required to maintain 6 feet of physical distancing while at Peoplefit. This will affect building and room capacities and availability of equipment.

In reviewing the Member Safety Agreement, I agree to adhere to the Peoplefit safety protocols, which may be updated over time, each time I visit the facility. I acknowledge the health risks and dangers associated with the transmission of the COVID-19 virus, and other communicable diseases, and recognize that exposure to the COVID-19 virus, or other communicable diseases, could occur while utilizing my membership or participating in programs offered by Peoplefit. With full awareness and appreciation of the risks involved, I, for myself and on behalf of my family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives, hereby release, waive and discharge, and to indemnify and hold harmless, Peoplefit and its employees and affiliates from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, or injury, including death, that may be sustained by me related to COVID-19 whether caused by the negligence of Peoplefit, any third-party using the Peoplefit facility, while participating in any activity while in, on, or around the Peoplefit facility and/or while using any of Peoplefit’s equipment, or materials.
